# Chief's Report

# Fire and Ambulance Report – Chief Tucker

February 2023, the department responded to the following:

- 22 total calls
- 2 fire
- 13 medical
- 5 ground transports
- 0 air transports
- 3 move-up
- 4 public assists
- 11 mutual aids

- 2 duty officer responses
- 3 move-up calls
- 28 PC's
- Year-to-date calls 53 (6 more than YTD 2022 and 6 more than YTD 2021)

# Inquiries on F&A Report:

- Fireplace ashes were set in a paper bag and placed outside on the deck, causing the deck to catch fire and causing minimal damage to the front side of the building.
- For the fire on the Ranch, we took an engine/medic. We communicated with partners in NW Fire and have determined that every time we have four or more personnel here at the station, we will respond to a structure fire with an engine and the ladder truck. Sisters-Camp Sherman Fire will respond with an engine and a medic, and Cloverdale Fire will respond with an engine.
- 2-3 medical calls were in Sisters.
- Currently doing a lot of driver training with crews to understand better the Ranch and where we can and cannot get equipment through, and best place to park apparatus.
- Dave Gibson stated the cul-de-sac tree hazards are being addressed.

# Temporary FF/EMT-P Position Filled

Josh Guintu has filled the temporary FF/EMT-P position. Chief is happy to have him on as he did a great job as a temporary.

#### **Firewise Report**

Lot certification has been a focus for the Firewise group.

The Tree Amigos have some opportunity for grant extension to remove trees. The state of Oregon is also putting another \$21 million for wildfire mitigation within Oregon.

In April, an email will come out regarding the importance of needle clean-up. Free needle pick-up will begin June 1, 2023.

### **President's Report**

Rodger expressed concern about a couple of camp trailers that seem to have been there for an extended period across from Indian Ford Road. Is this a concern for BBR especially if they have campfires? The general rule is a camper can only be in one location for 14 days out in the forest. The problem is there is only one enforcer of the rule in Deschutes County. That person generally spends much time in SE Bend and East of Redmond.

# GM 13 – Update

Rodger will be out of the area for a few weeks and unavailable to sign the GM13 sale documents. Depending on what the Ranch does with GM13, there may be a burn-to-learn opportunity.

#### **NEW BUSINESS**

# FY 2022/23 - Budget Error

Found an error in the current budget under EMS capital items for \$15,372. It's ok because it is all in capital. We also budgeted \$5,000 for our share of the grant for cardiac monitors. Our portion will be \$954. We may need to go over the \$5000 by \$2302.12 to allow six years of service. Overall \$56,945 remaining in capital. Chief Tucker asked for authorization to move funds within capital.

**Motion:** Larry Stuker moved to allow Chief Tucker to move funds within capital to accommodate the budgeting error, seconded by Don Bowler, unanimously passed.

#### **Budget Outlook – (Discussion)**

Chief Tucker said inflation seems very visible while planning the 2023/2024 budget.

#### **Resident Volunteer Program (Discussion)**

BBR RFPD is looking at being super competitive with the RV program. The department is trying to ensure the students are taken care of while complying with all the alphabet agencies.

The department proposes to have the up-and-coming RV's attend an accelerated EMT program at Unitech (technical college) in Tempe, Arizona. The students will get their EMT in 3-4 weeks versus seven months. The students would fly down on July 15, 2023, and return home on July 30, 2023. Tom expressed concern about having them away during fire season, but fire season peaks from mid-August to mid-September. The new RV's will hit wildland hard right when they come on board in June. The Firefighter I Academy will go until the week prior to school starting at COCC.
