APPROVAL OF MINUTES

Motion: Tom Sawyer moved to approve the May 25, 2023 meeting minutes as presented, seconded by Don Bowler, unanimously passed.

REPORTS

Treasurer Report

Comments/Discussion on Treasurer Report:

- Revenues are up nicely.
- Inquiry on Smith aerial class of \$1095; the class is a requirement of the job.
- Inquiry on Department of Justice. This is a child support payment.

Motion: Don Bowler moved to approve the May 2023 financial reports as presented, seconded by Tom Sawyer, unanimously passed.

Chief's Report

Fire and Ambulance Report – Chief Tucker

May 2023, the department responded to the following:

- 41 total calls
- 6 fire
- 15 medical

- 7 ground transports
- 1 air transports
- 2 move-up
- 18 public assists
- 8 mutual aids
- 5 duty officer responses
- 0 move-up calls
- 18 PC's
- Year-to-date calls 145 (27 more than YTD 2022 and 21 more than YTD 2021)

Comments/Discussion on F&A Report:

- June was the third busiest month.
- Of the air transport calls, one landed, and the 2nd was called off.
- Seasonal staffing is in place.
- Redmond invited the department to participate in an all-hazards drill; however, no one was able to attend.

Chief Ellison discussed:

Strategic Planning & Goals

D/C Ellison spoke on the following strategic plan and goals:

Recruitment and Retention – past student F/F Guintu is the departments newest FF/Paramedic but will be leaving to pursue another opportunity. F/F Schuhmann has been offered to fill the soon-to-be open position. She is currently not a paramedic but is actively pursuing her paramedic license.

Chief Ellison also reported:

The three new Resident Volunteers are wildland training for 2-3 weeks and then will leave to attend an accelerated EMT program in Arizona.

There is a lot of discussion on pine needles and how far they should be cleared from the home. OSFM recommends 100 ft., or to the property line.

It is costing BBR \$100,000 to dispose of the needles from the free needle pickup.

There may be an opportunity to address the gravel road that goes to Cold Springs Rd. by partnering with CEC and the Forest Service.

D/C Ellison was asked about his thoughts on an emergency siren in BBR. He feels it could be a good or bad thing.

Firewise Report

Rodger inquired if the Fire Department should be the source of knowledge for setting the standard on pine needle clean-up. D/C Ellison pointed out that OSFM is who the department takes recommendations from regarding topics like pine needle clean-up.

OSFM will becomes its own agency on July 1, 2023.

Three people who are on the Firewise Committee, are also on the BBR Board. This is good because they bring balance.

Because of Firewise, more people have complied with cleaning up their properties.

Tom inquired if the Ranch has an insurance waiver for those volunteering to do things like pick up trash and working with the trees. D/C Ellison is going to get clear confirmation on this.

Forest Management Report

The Forest Management Committee has identified how bad bitterbrush is on the Ranch. Dave Gibson and a few others are working on removing bitterbrush on the Ranch; however, it is all volunteer based.

Dave thought if the bitterbrush got under control now, it would be good for another 4-5 years.

At the Project Wildfire meeting a gal gave a presentation on controlled burns versus prescribed burns. It was good information to hear.

Larry recommended that the proceeds from selling x-mas trees this year should be used to pay people to help get rid of the bitterbrush.
